1.Introduction

Anglo Skills College has a strong commitment to widening participation and is committed to providing flexible and high-quality procedures that are accessible to students from all backgrounds. Students who have been identified as disadvantaged will be especially able to benefit from our Access and Participation Statement. It has been prepared in connection with the UK Government's Teaching Excellence Framework for new providers approved as fee capped category providers (without TEF Award) who intend to charge the basic tuition fee for Home/EU students commencing full-time undergraduate courses in 2018-19.

Currently, the Framework covers the national delivery of undergraduate courses, therefore this statement focuses mainly on the work of Anglo Skills College in the UK, however it also covers post graduate diploma courses and equivalent BTEC qualifications. We have been approved for the delivery of such courses by various prestigious UK awarding bodies. We are open to all individuals and groups as a wider part of community. This Agreement has been prepared in accordance with the guidance and requirements identified in Condition A1 of the OfS Regulatory Framework.

The college Senior Management Team have overseen and overviewed this statement.

Assessment of current performance

Anglo Skills College (ASC), established in April 2010, is a Tier-4 sponsored college from UKVI. We have been approved by the Independent School Inspectorate (ISI), an accredited inspection body for private schools and further education colleges since 2011. In the inspection we were awarded Grade 2 in all areas and we have continued to maintain Grade 2.

ASC is an education and training provider offering a wide range of accredited courses in various subjects from Level 1 to Level 7. We also deliver nonaccredited courses and short training. All our programmes and courses are career-oriented and designed for current global industrial demands, as well as the future needs of individuals. Therefore, our stakeholders are many and varied.

We deliver an extensive range of courses through vocational routes comparable with UK National Qualification levels in the areas of Business, Management, Human Resource, English Language, Travel and Tourism, Child Care and Health and Social Care as well as Information Technology. We offer NVQs for work-based learning courses ranging from L3 Awards to Diploma Level 3. ASC also offers BTEC Higher National Diplomas (HND) and Level 7(pre-master) Leadership and Strategic Management courses. All our BTEC degree level courses are accepted by most UK universities for progression to bachelor and master's degree programmes. They are also professional credentials which are recognised all over the world.

All ASC courses are available for all types of student communities, whether they are EU/Home students or international students. As a Tier 4 Registered Sponsor college, ASC offers all its courses to international students for Tier 4 general visa (CAS), short student visitor visa and long-term student visitor visa globally. Moreover, we are accredited by highly prestigious awarding bodies such as Edexcel, OCR, NCFE, City &Guilds, Highfields Awarding Body and many others.

The college operates and delivers all courses from its main dedicated campus.

We have to date worked with strategic partners in the community such as BEGIN Turn 2 US, the local council, ENABLE, Job centre Plus and community centres to attract students from diverse, especially disadvantaged backgrounds. We have enrolled several refugees and many people from underrepresented student groups. We have enabled them to gain access to the college here and have managed to ensure their continued progress on their courses and this has led to their success. Last year, for example, 40 students on our Child Care and Teaching Assistants course successfully completed their level 3 diploma (NVQ) and are now employed in relevant jobs. This group of students were funded by Advanced Learning Loans.

The college also runs a charity, The SEEDS foundation, dedicated to providing underprivileged children with better chances in life.

Ambition and strategy

College Commitment to Accessible and High Quality Academic Provision

Accessibility to All

Anglo Skills College is firmly committed to promoting equal opportunity and, in respect of student recruitment and admissions, the only considerations are that the individual is likely to meet the entry requirements of all courses and that the course meets the student's individual needs.

Anglo Skills College Nottingham (ASC) aims to promote and practise equal opportunities in its training, materials, publicity, and recruitment of staff and students in all aspects of its Service operation.  - Ensuring that all teaching staff identify opportunities in all the areas in which they work to adopt the best approach to the opposition to racism, sexism and all forms of discrimination as it might occur in course content, teaching styles and classroom organization and management for all student community of the college.

Our Approach to Meeting the Particular Needs of Individuals.

It is recognised that individuals may have particular needs related to equality and diversity matters. All equal opportunities related documentation pertaining to staff and learner activity will be retained within the Principal and Senior Management Office securely within 2tier locked storage facilities. Information provided by existing and potential learners or members of staff for monitoring purposes will be used only for this reason and will be dealt with in accordance with the Data Protection Act 1998.

Continuous Monitoring System to Measure Risks

The college has developed clear objectives towards student success and progress. In monitoring the effectiveness of our student admission and student recruitment procedures in reflecting our Equal Opportunity Policy, basic information relating to students' initial assessment, and needs analysis will continue to be gathered and analysed thereby providing organizational statistics in respect of all types of risk of under achievement; under representation, sex, religion or belief, race, colour, nationality, ethnic or national origin and disability. This data analysis is regularly monitored and tracked through the action plan.

Course evaluation and student feedback throughout the course is also used as a monitoring tool to measure risks and student improvement.

Individuals are under no obligation to provide such data; however, all information obtained in order to provide statistical information for monitoring purposes will be treated in the strictest confidence.

Should barriers to equality of opportunity relating to student activities be identified which highlight under-representation, the College will endeavour to take the necessary remedial action by a programme of positive action and support. Access, student success and progression measures

Ensuring All Students are Able to Access, Succeed in and Progress from Higher Education

ASC will endeavour to ensure that every student is enrolled on a course that is appropriate for them. No student will be disadvantaged and every effort will be made to help them succeed. In the event that a student appears to be failing a course, an intervention programme is agreed, and the college monitors the college closely until the individual is up to speed with the course.

All our courses are designed with the intention of meeting the future skills requirements. We monitor the progress of our students after they have completed their course to ensure that our courses are suited to the current job market or the requirements of higher education institutes.

Raising Attainment and Progression

A regular system of assessment will be put in place in all courses. Monthly assessments will be conducted to make sure students are meeting the requirements of the course. The aim of these assessments will be firstly to check learning is taking place and teaching has been effective, and secondly to guide teachers in the implementation of future classes. The feedback from assessments results will be used to plan subsequent learning. The highest standard will be expected of all students and every effort will be made to ensure high attainment throughout.

Anglo Skills College will ensure all the necessary steps are taken to maintain the quality of teaching and learning through the access and participation plan. The senior management team will monitor classes and teachers on a regular basis.

ASC will ensure all students have fair access to all materials throughout their lifecycle.

Timely cooperation between teachers and students on further education courses and NVQ courses supports us with high student retention. Success in these courses will enable our students to achieve attainment in other areas of education and the job market. The college also firmly believes success in each of these areas depends on the extent to which students are engaged, and that their engagement depends on their feeling of belonging to an institution which fosters their well-being and interests.

Investment

The total turnover for Anglo Skills College last year was approximately £72,510.00 pounds. We have plans in development for growth by 20% - 30% next year.

In 2018, ASC has secured additional access to government funding organisations. Due of our successful 100% achievement and delivery of funded courses through subcontracting, we have been approved by DWP to run the training and employability courses and community learning courses.

As we are a Tier 4 sponsor, we have secured approval from the Government of Saudi Arabia in Jan 2018 to provide English language courses and training courses to the students sponsored by the Saudi government for higher education, government officials and professionals. We are also listed on the ESFA training provider list.

Anglo Skills College has established a variety of routes to expand sources of funding to enable sustainability and development. Being officially recognised within the approved fee capped category by the OfS, we will be in a strong position to expand on our quality of educational delivery and anticipate our turnover to double.

During the last three years we have reinvested 30% of our income in upgrading our facilities. With 150 – 200 funded students we anticipate utilising approximately 30% of our income to improve our facilities and thereby enhance our accessibility for all students. Computer hardware and software is a priority for upgrading.

As a small to medium sized college we aim for all disadvantaged groups in a manner appropriate to our capacity. If approved for OfS funding, we would be in a strong position to broaden our scope to include an increase of such groups.

Provision of information to students

Transparency and Accessibility of all Information for Students

Anglo Skills College demonstrates transparency of information for its students of all diverse backgrounds. We ensure all our marketing material and social media sources and websites reflects our ethos of equality and diversity. Details of all our courses are freely available to potential students. We provide detailed descriptions of course content thus enabling students to make informed choices about their studies.

Our staff will also provide guidance for students to help them decide whether they will be able to cope with the demands of the courses and whether the courses are suitable for their future career plans. The utmost care will be taken to ensure that no student is on a course to which they are not suited. If a student finds that they are on a course which they believe does not meet their requirements, he or she will be offered an alternative where possible.

Anglo Skills College undertakes to keep students informed of any possible sources of funding that may be available to them to support their studies and maximise financial student support.
